

## IN CONGRESS, JULY ~~June~~ 25, 2017 1776

### The ~~unanimous-appointed~~ Declaration of the ~~thirteen-fifty~~ united States of America, and on behalf of sixteen territories and the District of Columbia, without their consent but to which they are obligated to abide



When in the Course of human events it becomes necessary for one people to ~~dissolve~~ factionalize the political bands which have connected them with another and to assume among the powers of the ~~dollarearth~~, the separate and inequal station to which the ~~Laws of Nature and of Nature's God~~ commerce entitle them, an indecent ~~dis~~respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men of North Western European descent are created equal generally similar though of distinctly different value depending upon their respective assets and net worths, that they are endowed by selectively enforced federal and state law ~~their Creator~~ with certain unalienable Rights, that among these are Life Wealth, Liberty Acquisition and the pursuit of Happiness Acclaim. — That to secure constrain these rights to this specific population, Governments are instituted among the above-described Men, deriving their just powers from the consent of the governed (so long as the governed vote in accordance with the preferences of the wealthiest two percent of the overall population of Men of North Western European descent). — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People Corporations with the Greatest Financial Holdings to alter or to abolish it in their economic interests, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness Domination over the socioeconomic minority. Prudence Greed, indeed, will dictate that Governments long established should not be changed for high decent and transient-noble causes, but for those that serve the interest of profit-seeking and private economic expansion; and accordingly all experience hath shewn that mankind are more disposed to suffer, while evils are sufferable than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations to long-established cultural marginalization of minority populations and women, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right fault, it is their duty fatal flaw, to throw off such Government, and to provide new Guards for their future security suffer the consequences of seeking to secure rights and opportunities similar to those of Men of North Western European descent. — Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present immediate former President of the United States of America King of Great Britain is a history of repeated injuries and usurpations of the Domination of White Men, all having in direct object the establishment of an absolute Tyranny over these States commonly accepted cultural norms and consistently implied and enforced laws that protect the tradition of assigning Heterosexual White Males full control over all other People of the United States. Now, a New President of the United States and those who have committed loyalty to Him above all Natural and Federal Laws, sets forth a new charter to return the United States to its trajectory as established prior to the Civil War. To prove this, let Facts be submitted to a candid world.

He has refused his Assent to Laws, the most wholesome and necessary for the public good.

He has forbidden his Governors to pass Laws of immediate and pressing importance, unless suspended in their operation till his Assent should be obtained; and when so suspended, he has utterly neglected to attend to them.

He has refused to pass other Laws for the accommodation of large districts of people, unless those people would relinquish the right of Representation in the Legislature Free Speech, Expression and Assembly, a right inestimable to them and formidable to tyrants only.

He has called together legislative bodies at places unusual, uncomfortable, and distant from the depository of their Public Records, for the sole purpose of fatiguing them into compliance with his measures.

He has dissolved-denigrated and ignored Representative Houses repeatedly, for opposing with manly firmness his invasions on the rights of the people.

He has refused-intends to refuse for a long time, after such dissolutions, to cause others to be elected, whereby the Legislative Powers, incapable of Annihilation, would have returned to the People at large for their exercise; the State remaining in the mean time exposed to all the dangers of invasion from without, and convulsions within.

He has endeavoured to prevent the population of these States by refugees of other nations that violate Natural Human Rights; for that purpose obstructing the Laws for Naturalization of Foreigners; refusing to pass others to encourage their migrations hither, and raising the conditions of new Appropriations of Lands, which he intends to assign as a King of England to lords who genuflect toward him, espousing prescribed superlatives including but not limited to "it is a blessing to serve your agenda."

He has obstructed the Administration of Justice by refusing his Assent to Laws for establishing-upholding Judiciary Powers.

He has made Judges dependent on his Will alone for the tenure of their offices, and the amount and payment of their salaries.

He has intent to have erected a multitude of New Offices, and sent hither swarms of Officers to harass our people and eat out their substance.

He has kept among us, in times of relative peace, Standing Armies without the Consent of our legislatures in the guise of local police forces and airline employees to intimidate, harass and execute at will any individual of non-North Western European descent, any biological or other individual who identifies as a woman or non-heterosexual male.

He has affected to render the Military independent of and superior to the Civil Power.

He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his Assent to their Acts of pretended Legislation:

For quartering-planning to quarter large bodies of armed troops among us:

For protecting them anyone at his command or agreement, including representatives of foreign nations with whom he has undisclosed financial dealings, including representatives of nations of historic and present antagonistic relationships with the United States of America, by a mock Trial from punishment for any Murders which they should commit on the Inhabitants of these States:

For increasingly cutting off our Trade with all parts of the world:

For imposing Taxes-Kellyanne Conway and Stephen K. Bannon on us without our Consent:

For depriving us in many cases, of the benefit of Trial by Jury:

For transporting us beyond Seas to be tried for pretended offences:

For attempting repeatedly to abolishing the free System of English-American Laws in our own neighbouring Province, establishing therein an Arbitrary government, and presumably planning to enlarging its Boundaries so as to render it at once an example and fit instrument for introducing the same absolute rule into these Colonies

For taking away our Charters, abolishing our most valuable Laws and altering fundamentally the Forms of our Governments through executive orders, firing of law enforcement and judiciary officials who have insisted on following the Rule of Law rather than his inconsistent and sometimes indecipherable whims:

For alternately intimidating and suspending our own Legislatures, and declaring themselves invested with power to legislate for us in all cases whatsoever.

He has abdicated Government here, by declaring the majority of us out of his Protection and waging War against us.

He has plundered our seas, ravaged our coasts, burnt-marred our towns, and destroyed the lives of our people with glistening and opulent edifices bearing his own name.

He is at this time transporting large Armies of foreign Mercenaries on a toilet, regarding Fox and Friends and firing off tweets to compleat the works of death, desolation, and tyranny, already begun with circumstances of Cruelty & Perfidy scarcely paralleled in the most barbarous ages, and totally unworthy the Head of a civilized nation.

He has constrained our fellow Citizens taken Captive on the high-Seas to Wall, North and South Capitol and K Streets to bear Arms-Political Tyranny against their Country, to become the executioners—today figurately and tomorrow literally—of-of their friends and Brethren, or to fall themselves by their Hands.

He has excited domestic insurrections amongst us, and has endeavoured to bring on the inhabitants of our frontiers most cruel districts, the merciless Indian Savages Corporate Executives whose known rule of warfare, is an undistinguished destruction of all ages, sexes and conditions.

In every stage of these Oppressions We The Sociopolitically Advantaged have Petitioned for Redress Greater Advantage in the most humble terms: Our repeated Petitions have been answered only alternately by repeated injury and flattery in return for genuflection. A Prince, whose character is thus marked by every act which may define a Tyrant, is unfit to be the ruler of a free people.

~~Nor have We been wanting in attentions to our British brethren. We have warned them from time to time of attempts by their legislature to extend an unwarrantable jurisdiction over us. We have reminded them of the circumstances of our emigration and settlement here. We have appealed to their native justice and magnanimity, and we have conjured them by the ties of our common kindred to disavow these usurpations, which would inevitably interrupt our connections and correspondence. They too have been deaf to the voice of justice and of consanguinity. We must, therefore, acquiesce in the necessity, which denounces our Separation, and hold them, as we hold the rest of mankind, Enemies in War, in Peace Friends.≡~~

We, therefore, the Select Heterosexual White Male Representatives of the united States of America, in General Congress, Assembled, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by Authority of the good People of these Colonies Our Personal Financial Interests, solemnly publish and declare, That these united Colonies States are, and of Right ought to be Free and Independent States More Profitable to We the People Who Matter Most, that they are Absolved Newly Committed to from all unconditional Allegiance to the British Crown of the Newly Self-Appointed Emperor of the United States, and that all political connection between them and the State of Great Britain Former Constitution of the United States of America, is and ought to be totally dissolved; and that as Free-Constrained and DIndependent States, they have lost any full Power to levy War, conclude Peace, contract Alliances, establish Commerce, and to do all other Acts and Things which Independent States may of right do. — And for the support of this Declaration, with a firm reliance on the protection of Divine Providence, we mutually pledge to each other our Lives, our Fortunes, and our sacred Honor, so long as it is permitted by the New Emperor, at his discretion, with or without sense, reason or competent articulation.
